"We are in a climate moment now," author and environmentalist Bill McKibben said recently at a talk in Montpelier, VT, "It feels different than any other moment since I began working on climate change thirty years ago. It's crucial that we don't waste it." He continued, emphasizing that "We all need to do the absolute most we can do. We all need to go outside our comfort zones and take action, because," he added, "the planet is 8 miles outside its comfort zone."
